


Did you attend the January 20th Facility Meeting for the Centerville Community School District? 48 responses




Are you a parent of a former student? 48 responses




Are you a parent or guardian of a current student who attends one of the schools in Centerville Community School District?




Are you a grandparent of a current or former student? ⁴⁶ responses




Are you currently a student? 46 responses




Do you live in the Centerville Community School District? ⁴⁸ responses




District Education

The district adequately prepares students to contribute positively to society ⁴⁶ responses




Of the 10 survey respondents who submitted comments:

- 2 expressed concern about property taxes










Of the 37 survey respondents who submitted comments.....

- 4 identified the cafeteria and commons area as a priority






















The facility has adequate access to technology




If improvements were made to this facility, the top priority would be: Of the 30 survey respondents who submitted comments.....

- 4 commented on the addition of classrooms for a 3-year old program with 2 in favor and 2 not in favor








