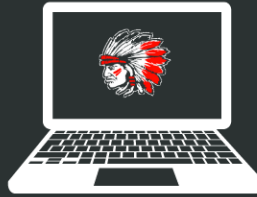

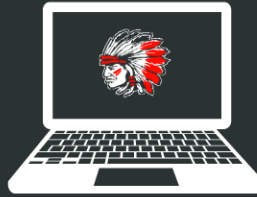

The Centerville Virtual Learning Academy believes in connection to community and school. This is why the program consists of two parts.

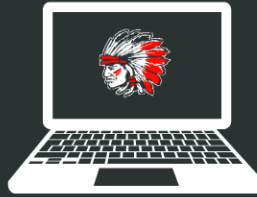
- 1) Connection to the RedTogether community through advisory/community virtual meetings with the student success coordinator and similar age/grade-level peers. This provides socialization, connection, social emotional learning activities, lessons in how to be successful in an online environment, and information about school activities. Students are eligible to join clubs, play sports, and participate in a variety of activities offered in Centerville Community Schools.
- 2) High-quality academic learning through customized Edgenuity Instructional Services to include the following:
  - Virtual courses will utilize Edgenuity’s award-winning curriculum, which meets both Common Core and state standards and is designed to fully engage and challenge students through rigorous content delivered by interactive, media-rich instruction.
  - Highly qualified, certified virtual teachers will instruct, remediate, motivate, and proactively communicate with students.
  - Qualified Concept Coaches will provide on-demand tutoring and engagement to ensure students’ questions are addressed in a timely manner, while Edgenuity’s Success Coaches will provide an additional layer of support for students who are enrolled in virtual courses full-time.

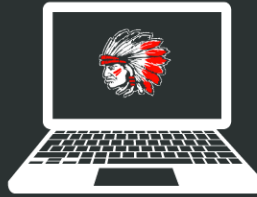

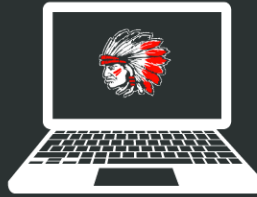

## SCOPE, DELIVERY, AND COURSE OFFERINGS

Centerville Virtual Learning Academy courses are available through Edgenuity, which is a virtual provider approved by the Iowa Department of Education. Edgenuity provides an elementary program that includes core courses and electives. Elementary students will be completing the four core academic areas (literacy, math, science, and social studies), PE/Health, Music, and Art (grades 2 to 5 only). Edgenuity provides a Secondary program for grades 6-12 that includes core courses, electives, Advanced Placement courses, Spanish, and Career and Technical Education courses. Centerville's Virtual Learning Academy provides everything a student needs to earn a district-approved diploma. See Virtual Learning Academy course catalog for more information.

The Centerville Virtual Learning Academy is not a stand-alone school. Each student will be officially enrolled in the Centerville Community School District and assigned to the appropriate school within the district.

Students will be eligible to be part of extra-curricular activities including athletics, clubs, or school-sponsored activities that occur outside the school day, as long as they meet all eligibility requirements.

- Centerville resident and open enrolled students may participate in all *Centerville* clubs and activities as long as they remain in good academic standing and meet all eligibility requirements. This is no limit to the number of Centerville Activities resident students may participate in.
- Open enrolled into the Centerville Virtual Learning Academy have additional requirements.
  - Open enrolled students may participate in two *resident district* activities.
    - For co-curricular activities, one semester equals one activity. Participating in vocal music 2 semesters equals 2 activities.
    - Additional activities are allowed at the discretion of the resident district.
    - Must maintain all eligibility requirements to participate.

Transportation outside of the normal bus routes will not be available.

High school juniors, seniors and some other qualified students may enroll in concurrent enrollment courses offered through local colleges/universities. However, these courses are controlled by the college and students must meet all expectations for the course in order to participate and are outside of the Virtual Learning Academy. This means if the

college determines the courses will be instructed in the face-to-face format, the student must attend class face-to-face with the assigned instructor and meet all expectations in order to earn the college credit. Students that elect to not participate in these classes but instead take a virtual alternative course will not earn college credit for the course.

**Each student will be assigned to a Centerville Virtual Learning Coordinator.** The Virtual Learning Coordinator will work with the student to make sure the student has everything needed to be successful in the courses. The Virtual Learning Coordinator will be the teacher of record for students, record attendance and grades. In addition, the Virtual Learning Coordinator will lead community meetings, track progress, communicate with families, connect students to additional help, and guide them through the course. The Coordinator will also provide important information about the school such as testing dates, requirements, and locations.

The Virtual Learning Coordinator will work with students in grades 6 to 12 to ensure they are connected to CORE subject area teachers in the event they need assistance and feedback to supplement the Edgenuity courseware.

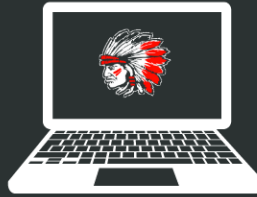
## ROLES AND RESPONSIBILITIES

### Parent/Guardian

- Maintain communication with Centerville Virtual Learning Academy learning coordinator teacher(s), and student success coordinator to ensure student success.
- Maintain accuracy of home address, phone number(s), and email address(es)
- Create a PowerSchool Parent Portal account through the Centerville Community School District website.
- Establish an acceptable environment and/or workspace for the student to be successful in a virtual format including helping the student with time management.
- Assist the student in making proper contacts for any technology needs and/or issues.
- For students in grades K through 5:
  - A responsible adult that helps the student access the content and ensures proper materials are available (Home Learning Coach).

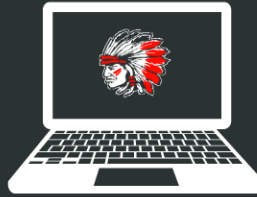

Students will communicate via the Centerville Community School District issued email-NOT through the Edmentum Courseware.</li> <li>● <b>ACADEMIC HONESTY:</b> Centerville Virtual Learning Academy requires the original work of all students and in so doing, prohibits plagiarism of the work of others and cheating. Students are expected to properly cite the origin of the work that is not the student’s own. If work content, other than commonly known facts, is not properly cited, attributed, or credited, the work may be determined to be plagiarism. The student will not have or allow another to complete their work. The student will follow the Student Code of Conduct.</li> <li>● <b>SELF-MOTIVATION:</b> Students can direct their own learning environment and procedures to fulfill course requirements enabling them to achieve individual academic success.</li> <li>● <b>INDEPENDENT LEARNING-STYLE:</b> Virtual courses give students the opportunity to set their own pace (within the semester timeline) for learning eliminating the stress of feeling rushed or pressured during the learning process, however, students <b>MUST</b> attend community meetings, individual meetings and other required lessons for attendance purposes.</li> <li>● <b>TIME MANAGEMENT SKILLS:</b> Students can do their coursework whenever it is best for them each day, but they must set aside an adequate and realistic amount of time to complete course requirements.</li> <li>● <b>PACE:</b> All courses have a pacing guide for modules and assignments. These guides assist the student to manage time realistically and effectively.</li> <li>● <b>PERSONAL COMMITMENT:</b> Because this learning environment has no bells to begin and end classes, students must have a personal desire to learn and achieve knowledge and skills via virtual courses.</li> </ul>

## STUDENT REGISTRATION & ELIGIBILITY

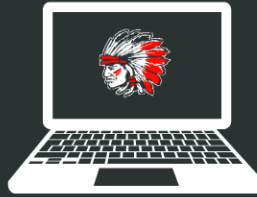
The Centerville Virtual Learning Academy adheres to all school board approved district policies. These can be found on the [CCSD Website](#).

### Student Registration

- Students must be registered with Centerville Community School District through the PowerSchool registration system.
- Centerville Virtual Learning Academy application is due by the first Friday in August to participate during the 2021-2022 school year. Parent/guardian signature is required.
- Students are expected to engage in learning through the Virtual Learning Academy for the entire semester. At the end of the semester, students will have the opportunity to return to face-to-face instruction. Each family will receive a survey at the end of the semester to determine the intent to continue in the Virtual Learning Academy for the next semester. The schedule below also encompasses the application window for students requesting to move from face-to-face to the Virtual Learning Academy.
- Book Fees will still apply to the Virtual Learning Academy and need to be paid through our website or at the administration office.
  - K-5: \$25.00
  - 6-12: \$35.00

## Student Eligibility

Students and parents/guardians are required to sign and abide by the code of conduct linked below. Students need to complete course requirements within each nine week quarter time frame and meet attendance guidelines in order to continue in the program. Additionally, students need to participate in state testing requirements as discussed in the testing section. If a student does not attend, does not make adequate progress, or does not follow the code of conduct, contact from the Coordinator and/or Virtual Director will occur.

Students are eligible to enroll in courses based upon academic appropriateness as determined by the student, parent/guardian, school counselor, and school administrator. Students may be placed in courses in order to meet graduation/promotion requirements, acceleration needs, and/or remediation needs. Students must meet prerequisites for course enrollment. Students and families are encouraged to work with their school counselor to determine their academic plans and their eligibility for educational programs. [CODE OF CONDUCT](#)

Students are required to be considered enrolled full-time, complete graduation requirements in a timely fashion, complete courses, and accrue credit toward ontime graduation.

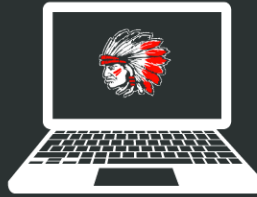
## Withdrawal From the Virtual Program

Each student has the opportunity to return to face-to-face instruction at the end of the semester according to the schedule described above, under student registration. Students are also expected to meet the minimum goals below in order to remain in the program. The Centerville Community School District retains the right to remove students that do not meet the minimum goals from the Virtual Learning Academy and reassign to face-to-face instruction.

### Minimum Goals

1. Student and family adhere to the Virtual Learning Academy Handbook and complete the assurances survey (will create and link a Google Form)
2. Meets required instructional hours for attendance (see attendance section)
3. Remains in good academic standing which includes making adequate academic progress

4. Participates in state required testing and progress monitoring even when on-site proctoring is required
5. Adheres to the Code of Conduct

## MTSS-Multi-Tiered Systems of Support

MTSS is a process by which schools use data to identify academic supports for each student in order to meet their individual needs. The process provides students with targeted interventions and monitoring of progress with a focus on helping all students reach high levels of proficiency on essential Iowa Core Standards. This process takes place within universal, target, and intensive levels of instruction and support. Each of these levels provides increasingly intensive interventions based on the student's needs. The table below describes these three tiers of support in the Centerville Virtual Learning Academy.

## ATTENDANCE

### Attendance

Good attendance is an integral part of the learning experience and is required of all students to receive the maximum benefit of the educational program. While the Centerville Virtual Learning Academy is intended to provide an academic environment that promotes independent learning and greater flexibility over when and where this learning takes place, an attendance structure is required. Attendance in the Centerville Virtual Learning Academy includes working consistently in all courses through the virtual curriculum, attending scheduled community meetings, attending required CORE subject area lessons, completing course lessons and activities through Edgenuity, and making adequate progress in all enrolled

courses. Anytime students, parents/guardians, At-Home Learning Coaches, and/or Centerville staff are concerned about a student's attendance, contact the appropriate party for a problem-solving conversation. Certain absences may be excused under this policy with communication from the parent/guardian, but students will still be expected to make up work due to an absence and complete coursework by deadlines. ## **Attendance Requirements**

1. Students in the Centerville Virtual Learning Academy are required to attend scheduled community meetings with their Student Success Coordinator and similar-aged students. The meeting will include socialization, study skills, social skills, social emotional learning lessons, and instruction, as needed. Meeting schedule will be provided by the Student Success Coordinator. Non-attendance of a community meeting will result in an unexcused absence for that class for the specific day.
2. Students must login to the Centerville Virtual Learning Academy curriculum and make active progress everyday the Centerville Community School District is in session for at least 4 hours. If this participation does not occur, the student will earn an unexcused absence. Participation and active engagement will be determined each Monday for the previous week.
  - a. All no school breaks experienced by face to face students will also be in place for the Centerville Virtual Learning Academy students.
  - b. If the District has a snow day, you will be informed by the district and information about attendance and work completion will be shared.

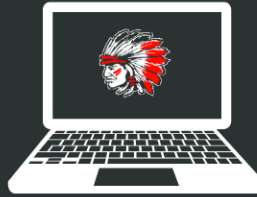
It is also important to note that while an online format will provide more flexibility in pace and daily/weekly work time, students will be held to the same yearly calendar as students in traditional school settings. As with students in traditional school settings, parents/guardians of virtual students are responsible for their student's virtual (online) attendance per Iowa Code. The school district will monitor student attendance and progress, provide support, and communicate concerns. Still it is the family's responsibility to make sure a student is attending regularly and making adequate academic progress as defined by district expectations. Anytime students, parents/guardians, teachers, and/or administrators are concerned about a student's attendance, they are encouraged to contact the appropriate party.

Students that do not meet attendance requirements will be counted absent. Communication from parent/guardian is required for excused absences. Excessive absences both excused and unexcused will result in communication from Centerville Community School District Staff. Attendance letters and truancy law will be followed according to district policy.

## GOOD ACADEMIC STANDING

A student demonstrating adequate participation (and therefore progress) in school is based on several criteria and is a combination of measures. These measures include:

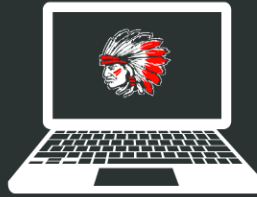
- Active engagement/participation in the courseware for at least 4 hours each school day.
- Assignment and module completion.
- Student engagement.
- Course percentage completion.
- Communication with the Teacher/Coordinator.
- Participation in both large group (community/advisory meetings, subject area class meetings, etc.) and small group (intervention meetings, extension meetings, etc.) activities.

Students are expected to submit assignments in each course every week school is in session. A student is in good academic standing based on weekly progress and work submissions as defined by course pace charts, percent complete, attending community meetings, and regular communication with the Coordinator. Therefore, even though a student may be recording the required daily logins, failure to make adequate weekly progress and/or regular communication with the Coordinator may place the student at risk of failing courses, retaking courses, not moving to the next grade-level or being removed from Centerville Virtual Learning Academy.

Failure to make adequate weekly progress places a student at risk. For both elementary and secondary students to maintain progress, the parent/guardian must ensure the following:

- Student completes assigned lessons and assessments.
- Student participates in educational activities at the required times and for the appropriate number of hours.
- Student maintains at least weekly communication with the virtual learning coordinator.
- Student attends all mandatory state testing.
- Parent/guardian has communicated with the student's virtual learning coordinator in advance if he/she needs to deviate from the regular school calendar.

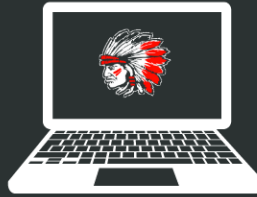
### Grading and Reporting

## **Grade-Level Advancement**

Students must meet all Centerville Community School district established requirements to advance to the next grade level or to graduate with an Centerville Community School District diploma.

## **Grade Reports**

Grade reports will be issued at the end of every semester. Parents/guardians can view the report card through the PowerSchool Parent Portal.

Questions regarding grade reports can be asked of the following:

- Virtual Learning Director
- Virtual Learning Coordinator

Parents/guardians and students are encouraged to check the parent portal of PowerSchool for ongoing updates, checking attendance, and virtual end of semester report cards. Parents are also encouraged to check the Edgenuity virtual curriculum gradebook regularly to monitor student progress.

## **Parent/Teacher Conferences**

Families will have the opportunity to engage in parent/teacher conferences virtually with the student's Learning Coordinator. Information will be provided each quarter.

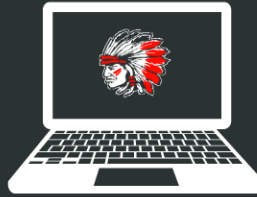
## **High School Grade Point Average (GPA)**

All grades each semester will be calculated into students' GPAs using the same procedure as in the past and in the face-to-face option. Transcripts will look the same. Colleges want GPAs to be an accurate reflection of student learning and understanding. Grades should correlate to a student's performance on high-stakes assessments such as the Iowa Statewide Assessment of Student Progress (ISASP) or ACT.

## **Right to Privacy Policy**

Centerville Community School District and the virtual curriculum provider respects a student's right to privacy by following the guidelines set forth in the Family Educational Rights and Privacy Act (**FERPA**). This law protects the privacy of a student's education records. CCSD must have written permission from the parent/legal guardian in order to release information from that student's education record.

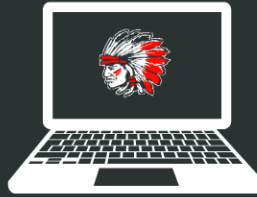
### Class Load

## STATE REQUIRED TESTING

### Requirements for State Testing

All students will be required to take all mandatory testing. Students must comply with all CCSD Student Testing guidelines listed in the code of conduct.

### Students are Required to Participate in the Following Assessments

- Edgenuity Courseware Assessments
- Iowa Statewide Assessment of Student Progress (ISAP) (3rd - 11th grades)
- English Language Proficiency Assessment 21 (ELPA 21) (English Language Learners)
- FAST Universal Screening Assessments (K - 8th Grades)
- FAST Progress Monitoring (K - 8, as needed)
- Dynamic Learner Maps (DLM) (Special Education Alternative Assessment)

### Proctoring of Assessments

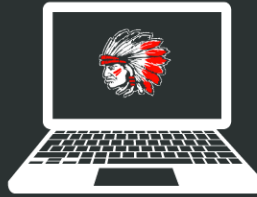
Some testing may only be available in the Virtual Learning Academy school building with the student's Virtual Learning Coordinator. It is the family's responsibility to ensure that students are transported to and from the testing site according to the testing schedule.

### FASTbridge Screening Assessments

Students in grades Kindergarten through 8th grade are required to take screening assessments in both reading and mathematics. This will require a scheduled time in a socially distanced face-to-face environment OR a scheduled virtual time to take the assessment with the Centerville Virtual Learning Coordinator and an At-Home Proctor depending on the grade-level of the student and family preferences.

- Grades K and 1
  - All testing needs to be administered 1 on 1 by the Centerville Virtual Learning Coordinator.
    - There will be both face-to-face and virtual time slots families can sign up for communicated by the Virtual Learning Coordinator
      - If proctored via Zoom an At-Home Proctor will help the student access the Zoom link and oversee the testing with the teacher from home.
        - This proctor will need to follow the [proctor procedures](#) at the time of testing and should be the At-Home Learning Coach for students in grades 2 to 5.

- Some testing may need to be administered 1 on 1 by the Centerville Virtual Learning Coordinator. Your coordinator will communicate if your student is required to test students in this way.
  - There will be both face-to-face and virtual time slots families can sign up for communicated by the Virtual Learning Coordinator
    - If proctored virtually, an At-Home Proctor will help the student access the Zoom link and oversee the testing with the teacher from home.
      - This proctor will need to follow the [proctor procedures](#) at the time of testing and should be the At-Home Learning Coach for students in grades 2 to 5.
- Some testing will be administered in groups by the Centerville Virtual Learning Coordinator either face-to-face in a socially distanced environment or virtually at a scheduled time.
  - Time slots for both face-to-face and virtual testing times will be communicated to families for sign up prior to the testing date.
    - If proctored virtually, an At-Home Proctor will help the student access the Zoom link and oversee the testing with the teacher from home.
      - This proctor will need to follow the [proctor procedures](#) at the time of testing and should be the At-Home Learning Coach for students in grades 2 to 5.

The Virtual Learning Coordinator will share proctoring information with families prior to the testing window each semester.

## **State Required Intervention and Progress Monitoring**

Students in grades K to 8 that are identified for intervention and progress monitoring through the Fast screening process are required by the state to participate in interventions and progress monitoring. These required times will be scheduled by the virtual learning coordinator.

## **ISASP Testing**

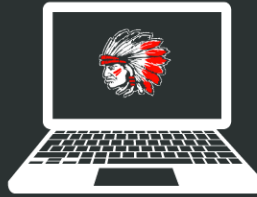
ISASP testing is the federal accountability test under the Every Student Succeeds Act (ESSA) and must be completed by all students in grades 3 to 11 in a face to face environment proctored by an Iowa licensed teacher. Virtual Learning Coordinators will provide information about testing prior to the testing window in April.

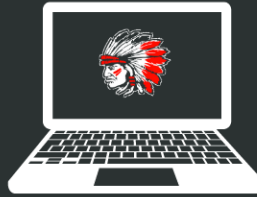

### **Talented and Gifted (TAG)**

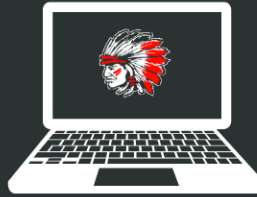
TAG students may elect to participate in the Centerville Virtual Learning Academy. The student and family will work with the TAG teacher to extend their education for appropriate challenge and growth.

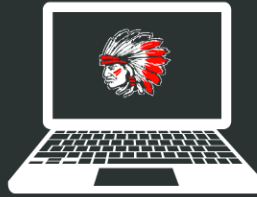
## **Co-curricular Activities**

## SCHOOL MEALS FOR CENTERVILLE VIRTUAL STUDENTS

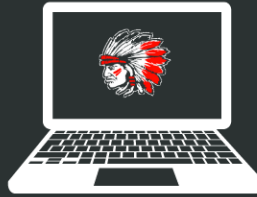
Students enrolled in the Virtual Learning Academy can participate in the school lunch program for breakfast and/or lunch.

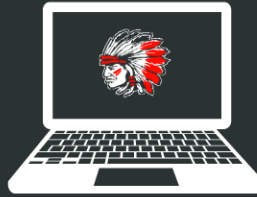
